MAAA Insurance Cover - Your obligations as a Financial Member

As a financial member of the Gold Coast Model Flying Club Inc. (GCMFC), the Model Aeronautical Association of Queensland Inc (MAAQ). and the Model Aeronautical Association of Australia Inc. (MAAA), you undertake to abide by the terms of the insurance policy and the general rules and bylaws for the flying and operation of your models.

Damage to Other Persons' Property

The current insurance policy has a \$5,000 excess payable for all claims. Should you have a legitimate claim you are required to complete the necessary forms, provided by the Club Secretary. In any claim you will be responsible for the first \$500 (unless under instruction), MAAA will pay the balance.

Injury to Another Person

Injury to another person (regardless of how serious the injury may be) should immediately be reported to the club Secretary or a Committee Member. This must then be followed up in writing using the Accident and Incident Report Form, available from the Club Secretary or MAAA web site.
